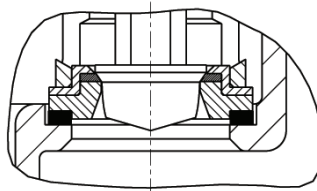

TFE-Soft Seat Design

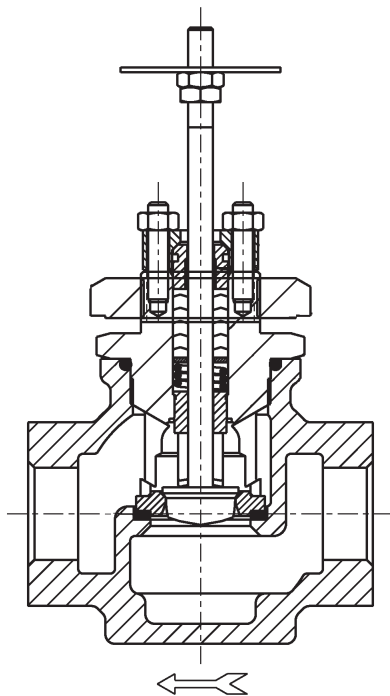

Metal Seat

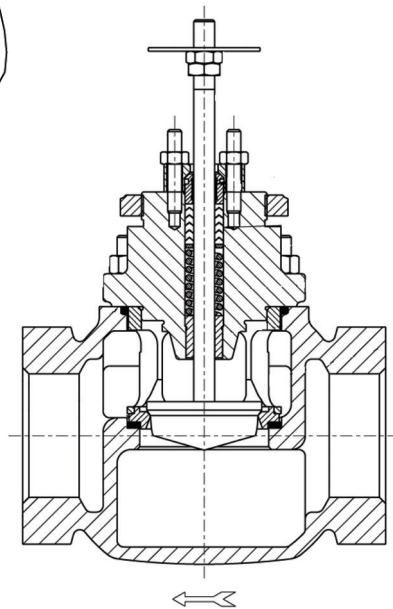
